GENERAL QUESTIONS:

“How much time should we set aside for portraits during the wedding day?”

Couples can be very pressed for time during the day itself, so it's good to think about what's important and set aside some time to capture timeless and meaningful images. As a guideline:

Preparations shots, 30 minutes for the girls, 30 minutes for the boys. Couple session, at least 45 minutes. Family formals, at least 45 minutes. Bridal party, 30 minutes to 1 Hour.

“When should we do our engagement portraits?”

If you wish to showcase the images in a Coffee Table Book or a Save-The-Date for the wedding, at least 3 months before the wedding date is a good to ensure there's sufficient time to work on the images. If timing isn't so critical, perhaps consider a post-wedding/honeymoon session!

“What if we go beyond the time agreed in the contract?”

Sometimes, those extra minutes at the end counts, which is why we will ask you before the end of the agreed timing if you'd wish to extend. Additional hours are charged accordingly.

“Do you deliver ALL the images you've taken?”

Not all images will be delivered. STP represents clients in the best possible light – so we take great effort to cull the images to ensure that the images shared are the worthwhile stories of the day. Only the photographer's selection will be included in the proof gallery, and the couple's selected images will be retouched and delivered as high-resolution digital copies.

“How many images do you usually take during a wedding? An engagement?”

These are highly variable; but typically, a rough estimate would be around 30 images per hour for an engagement, and about 40-60 images per hour for a wedding coverage in your proof gallery.

“What do you mean by “Retouched” images?”

All proof images in the gallery will be lightly processed, which includes light and color adjustments. Selected images will go through further artistic tweaks in signature STP style (see look and feel of images on the STP blog), and as well as moderate clean-up of blemishes, pimples, eye bags, and dark lines on skin.

“Can you make my arms smaller, or remove an entire object from the photo?”

STP can do these things in post-production. However, these are not covered under any of the packages. This type of work is very time intensive, and any custom post-production is charged by the hour.

“When can we expect to see our images?”

The proof gallery is released within 4 weeks from the shoot. Couples can then inform STP of their selected images through a viewing session, or through an online gallery. Galleries will be up only for 3 months.

Retouching of selected images will take about 2-3 weeks depending on the volume of work, and delivery of flash disk to clients follows immediately after that.

“What size can we print our photos from our digital images?”

Clients have the right to reprint images whenever and wherever they want. The digital images are optimized at best quality for 4x6 prints, and can print photos upto 8x12. However, clients are not licensed to sell the images, or publish the images without the written consent of STP. Doing so will be a violation of copyright laws.

“How long does it take to receive our coffee table book?”

Once clients have selected the images and spreads that will go into the coffee table book, printing and delivery will take 4-6 weeks. It is mostly dependent on how quickly couples come back with their selections. Some are able wrap-up within a month, while others take more than a year.

“For destination weddings, what is the travel surcharge for?”

For overseas shoots, clients are responsible for travel, accommodation and travel incidentals of the photography team. An additional travel surcharge goes on top of the travel expenses to provide adequate compensation for the time spent in transit, travel insurance, equipment insurance, and estimated delivery charges for the final images or albums.

“How do we reserve STP for our date?”

Dates and timings are reserved once STP receives a signed contract and deposit. A date will NOT be reserved based on an inquiry. Bookings are on a first come first served basis. So do book early to avoid disappointment.

“If the wedding is cancelled or postponed, can we get our deposit back?”

Deposits are used to reserve STP's time, and once a date is reserved, new clients who are interested in the same date are turned down in your favor. Because of that, deposits are non-refundable. If wedding dates are changed to a different date, deposits may be used towards a future date. However, if the rates have changed since the original agreement, the new rates will apply.

“How can we make payment?”

STP accepts payment in cash, cheque, or transfers. Feel free to contact info@steptan.com to coordinate confirmation of payment.
